- Daily meals will be provided; however, parents are to provide light snacks (apple, banana etc.)
- In an event where a parent wants to remove his/her child, a **one month** notice is to be served.
- We will be opened during school holidays to cater for those parents who cannot have their kids at home; however we will be closing on 15 December yearly.
- Parents are to provide their kids with the required stationary and we kindly advise that all parents participate in this regard.

Authorization for Medical Treatment:

I understand it may be necessary to have parental/guardian consent for my child in the unlikely event of an injury or condition requiring emergency medical treatment. In such a circumstance, I hereby give my permission to take my child to the nearest, available medical facility and have any necessary emergency medical treatment administered. Furthermore, if I cannot be reached I give my permission to the Educare Pre-School representatives to act on my behalf in seeking emergency treatment for my child, if it is deemed necessary or advisable for my child's health, safety and welfare by those professionals administering such medical treatment. I specifically release all such medical care providers, Educare Pre-School and their representatives from any liability in acting in such circumstances. The applicant shall remain liable for the costs incurred by such emergency medical treatment.

Activities: Attending Pre-School at the Educare centre

Sick Kids:

We acknowledge that children do get sick from time to time. Some sicknesses could be contagious, as a school we do not allow children who are sick to attend as this may put the rest of the children at risk of contracting the same bug/virus.

Medication Regulations:

Regulating medication is very important and should not be taken up lightly. It is for the safety of your child that we need to ensure that certain policies and regulations regarding medicine is followed.

School Rules: Medicine:

1. All medicine must be written in the communication book, if there are any missing information we will not be able to administer the medication. (Date, Name of Medication, Dosage, Method and times to be given, and lastly your signature at every time).
2. Medication given without a prescription will not be administered. (There must be a label on a bottle, child's name, indicating dosage and dates).
3. As we are parents, not Doctors we would not be aware if we overdose our children. As we do not know the components of each medicine.
4. If we do administer any fever medication and you did not provide us any written notice to do so, you will be contacted personally by the office to ask permission.

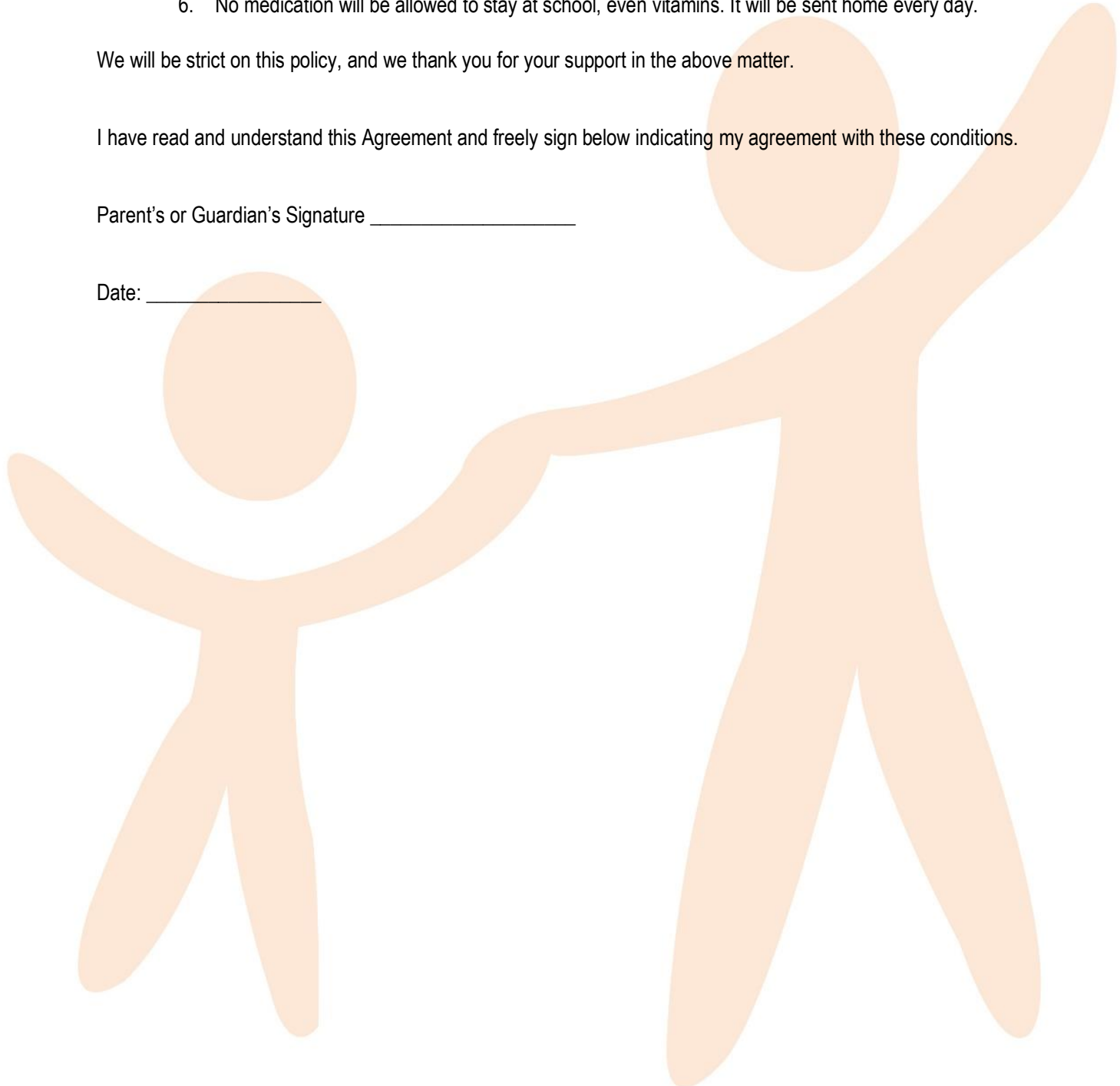
5. Medication must be given to the teacher by hand. Even if you make use of transport. This is for the safety of your child and will prevent your child from having access to medication without supervision.
